## **FAQ**

#### Why has our Club received this list of members?

Annual check to ensure that VIEW Clubs National Office has accurate membership information.

#### Who needs to complete this update?

Club Secretary working with Club Treasurer (and other Committee Members as needed) should update this list

#### When is this due back to National Office?

To ensure timely record updating it is requested that this be completed and returned to National Office by 31 March, each year.

### Can I just send my Club's current Membership list instead of updating the list sent by National Office?

No, each Club needs to update the list provided by National Office. It is a long process to update National Office Membership Database and to accept individual Club lists would mean having to compare our records to the list provided (times 268 clubs).

#### Do I need to do this on the hard copy, it would be easier if I had an electronic version?

Club Secretaries can request a Word Version of their Clubs Membership List from VIEW National Office for editing and submitting. Changes need to be marked in the document using Track Changes.

Documents that do not show changes will be returned to the Club Secretary.

#### Why do we need to include a Year of Birth, why not a Date of Birth?

To help keep VIEW members details safe, we only require a year of birth. A full date of birth can allow a misuse of members individual details if include with names and addresses. A Year of Birth provides the information required for Insurance compliance.
